**Project Description:** Notice of Intent to Adopt a Mitigated Negative Declaration

Located in the County of Riverside, California the proposed project consists of construction, operation, and maintenance of an underground storm drain system comprised of approximately 3,700 lineal feet of reinforced concrete pipe ranging in size from 48 inches to 72 inches in diameter and an outlet structure within Smith Creek. The purpose of the project is to provide storm drain facilities that can convey the one percent chance flood that emanates from the tributary watershed defined by the Banning Master Drainage Plan.
